

We are entering Year Two of a five -year transformation project, which includes the launch of Vermont State University in July 2023, as well as system-wide consolidation of certain administrative functions, such as Information Technology, Finance and Business Operations, and Human Resources. We are also looking to build on our already strong workforce development programs and opportunities.

We are interested in receiving feedback from a wide variety of students, including fulltime and part-time students, undergraduate and graduate students, in person and online students, student athletes, student parents, workforce students, in state and out of state students, residential and commuter students, students who manage disabilities, first generation students, students from historically under-represented groups, international students, etc.



# Vermont State Colleges Board Welcomes Two New Members

Announced in an August 17, 2022 press release, the Vermont State Colleges' Board of Trustees welcomed Castleton University sophomore Perry Ragouzis and State Representative David Durfee to the Board.

Representative David Durfee joins the Board of Trustees from Shaftsbury, VT and represents the Bennington-3 district in the Vermont House of Representatives. About joining the Board of Trustees Representative Durfee said "the Vermont State Colleges System is an integral resource for the people who live and work in this state. Joining the Board of Trustees is an opportunity to move the needle on meeting the needs of Vermonters. The upcoming unification of three Vermont schools from around the state ensures that students anywhere in Vermont can do anything, from earning a four-year degree in environmental studies, to completing career training as an HVAC technician. I am happy to bring my systems-level knowledge and experience with business and cooperatives to the board, and to advocate for the relevance and success of the system within the legislature."

Perry Ragouzis is a current student at Castleton University studying political science. The creation of Vermont State University means that we can bring together the best of our Vermont schools to form something entirely new. # Job Posting Announcement: Associate VP of Workforce, Community, and Economic Development


The position of Associate Vice President of Workforce, Community, and Economic Development has been posted internally. This position reports directly to the president of Vermont State University and will serve a key role in supporting VTSU's mission to become a national model for preparing careerready students. The work of this position will foster the evolution of VTSU as a workforce and economic development engine in communities across the state.

This position is an important one in this context and more. It will bring all existing programs related to Continuing Education, K-12, workforce, community, economic development, and business and industry partnerships on all the university campuses under a single umbrella. This will make coordination better across all campuses by increasing efficiency, cost effectiveness, compliance, and accountability.

The individual who fills this position will serve as the connection of workforce development within VTSU to the work that is being done throughout the Vermont State Colleges System (VSCS). They will work closely with the VSCS Executive Director of Workforce Development (whose role is to coordinate and expand workforce and continuing education opportunities across the system), the VTSU Provost, the College Deans, Department Chairs and faculty, the VP of Admissions and Enrollment Marketing, and the VP of Student Success to coordinate all workforce, community, and business development activities, programs, and initiatives.

The search committee is excited to begin reviewing applications. ## Updates from Transformation Project Teams



#### Message from the Academic Operations Team

The Academic Operations Core Team is looking forward to transitioning into a new structure with the appointment of Kelley Beckwith as Vice President for Student Success and completion of design elements from related sub-teams and working groups. Over the next two weeks, the team will be reviewing an expanded, integrated student success design with sponsors that includes all the functional areas of student success.

With significant effort by faculty over the summer, an initial group of 21 programs are now undergoing the coordinated review process by all curriculum committees and Faculty Assemblies. The General Education Group has also worked to incorporate feedback over the summer from faculty and academic operations transformation teams into a revised final proposal for Faculty Assembly review in the coming weeks. Projects to support unified VTSU academic scheduling and a single VTSU catalog are also now underway.

#### Message from the Administrative Operations Team

On the Facilities Team's side, there has been continued progress in the area of leasing and divestment of sites. A survey proposal was received from Civil Engineers, indicating some intensive sitework is required. Meetings are happening with Veteran Services, as well as other entities, to explore housing possibilities.

The Information Technology's team has a Statement of Work in progress for Business Intelligence Support resources. The Cyber Security project had their kick-off meeting. A reminder that the IT Shared Services leadership positions have been posted internally. Employees can access these and other positions by logging into UKG under My Company > View Opportunities.

#### Message from the Student Experience Team

New student move-in and orientation programs were a success at all our locations over the past couple of weeks. Over 40 new international students are starting their first semester at Castleton and were proud to be photographed in front of the Alumni Gate!

Admissions continues to prepare for the fall recruitment season. Boxes and boxes of new Vermont State University recruitment materials arrived on our campuses last week and are looking great! At this time, VTSU is confirmed to be at 280+ recruitment events in the northeast this fall. We expect the number to grow to around 300. In addition, there will be many high schools visited in the areas surrounding these regional events. Our team will begin their travel season over the next couple of weeks.

This past week, the Athletics transformation team presented their vision and design for varsity, club, and intramural athletics to the sponsors. In addition, they shared their vision of SHAPE facilities and services for Vermont State University. The Student and Residence Life team shared their vision and design for operating a new, unified approach to residential operations across our campuses. There was good conversation and the teams will await feedback regarding next steps.

#### Message from the Workforce Development Team

The Workforce Core Team is working on collecting data needs going forward, as well as looking at historical workforce development data. This will define current activity in this work and assist with setting benchmarks to measure future success. In addition, a smaller Strategy Team is working on a design outline for workforce development at the system-level under the Executive Director of Workforce Development. This bifurcation of the work should be a more efficient use of team members' time and meet upcoming deadlines.
