New to the VSC? The Vermont State College system is engaged in a five-year plan, the first phase of which was to launch the new Vermont State University. This new institution is comprised of what was Castleton University, Northern Vermont University, and Vermont Technical College and launched July 1, 2023. The second phase of transformation is focused on functional process optimization and systemwide administrative consolidation, including a shift to shared services for Information Technology, Human Resources, Finance, and Libraries. ## Message From the Chancellor



First, I want to recognize the incredible support of our campus communities, colleagues, and neighbors that employees across the system provided in response to last week's devastating floods. Our campuses provided a valuable place of refuge and we are continuing to host some emergency management and recovery agencies. In particular, I have received messages of thanks from those in the Johnson community, which was particularly hard hit. For employees who are continuing to struggle with the clean-up and recovery from the storms, please reach out to your supervisor or Human Resources if you need assistance.

Second, congratulations to Vermont State University on securing accreditation approval from the New England Commission for Higher Education (NECHE) on June 15, 2023. This was a huge accomplishment and critical to the successful launch of VTSU on July 1, 2023. NECHE's formal letter of approval is available here. NECHE has requested the submission of a progress report by October 30, 2023, and it will be conducting a focused evaluation/site visit in Fall 2024, plus a comprehensive evaluation in Spring 2027.

Third, thank you to all those who came out in support of Vermont State University at the press conference on July 6th at the Statehouse in Montpelier. It was a very hot day, but we had tremendous

### VTSU Presidential Search Update

Interim President Mike Smith's six-month term is scheduled to conclude at the end of October 2023. Given the short period of time in which to find the next President of Vermont State University and the nonalignment of the search process with the academic year, the Board of Trustees is moving forward with an abbreviated search process to identify and hire an experienced change management leader to serve as interim President for an eighteen to twenty-four month term. During this interim period, the Board will then conduct a full traditional academic search and hiring process to identify the next President of Vermont State University.

The Board has created an Ad Hoc Search Committee composed of five trustees to lead the search for the next interim President of Vermont State University. The Search Committee members are Trustees Bombardier, Dickinson, Durfee, Luneau and Tester. Other trustees are encouraged to participate in the meetings. The meetings are scheduled to be held every other Thursday at 8:30 a.m., with the exception of this week when, due to scheduling challenges, the Search Committee will meet at 2:00 p.m. on Wednesday, July 19th. The next meetings are scheduled for 8:30 a.m. on August 3rd, August 17th, and August 31st. The Search Committee's goal is for the hiring decision to be made at the Board's retreat on September 18-19, 2023.

Although this is a search for an interim President, we continue to explore ways to include stakeholder participation in the process.

### Updates on VTSU Leadership



Vermont State University has had a number of changes and updates to its leadership. Here is an update that was provided to the VTSU community.

#### Dean of Students - Jamia Danzy

Please welcome Jamia Danzy as the inaugural Dean of Students at Vermont State University. Jamia recently earned a Doctor of Education in Higher Education from the University of West Georgia, and also has a Master of Education in Higher Education from SUNY Buffalo. She brings a breadth and depth of expertise and over eighteen years of experience working throughout all areas of student affairs. Jamia's first day is July 10 when she will attend Vermont State Summer Days on the Randolph campus. Her primary campus is Johnson.

# Dean of Arts and Communication and Dean of Education, Psychology, and Social Sciences – David Kupferman

David Kupferman was formerly a full-time faculty member in Education at Minnesota State University Moorhead (2018-2023), a full-time faculty member in Education at the University of Hawaii-West Oahu (2013-2017), and an instructor at the College of the Marshall Islands (2004-2013). He also served as Dean of Academic Affairs from 2005-2009 at the College of the Marshall Islands. He has a Ph.D. in

Education from the University of Hawaii at Manoa and is currently completing his M.B.A. from Boston University. His home campus is Johnson.

#### Dean of Business and Professional Studies Cathy Kozlik

Cathy Kozlik has been employed at Castleton since 2004, starting as a part-time instructor, and then serving in successive roles as a full-time faculty member in Business Administration and as Associate Academic Dean, Academic Dean, Dean of the College of Business, Chief Academic Officer, and Campus Executive Director. She holds an M.B.A. from Champlain College. Her home campus is Castleton.

#### **Dean of Graduate Programs David McGough**

David McGough has been employed at Johnson since 2009, starting as an Associate Professor in the Education Department. His most recent roles include teaching for the Graduate Education program, serving as Head of School of Cultural and Human Studies, Director of the NVU Graduate Division, Program Director for the Master of Arts Foundations of Education Program, Coordinator for the Master of Education Program, Chair of the Interdisciplinary Graduate Program, and Program Director for the Master of Arts Leadership Studies Program. He holds a Ph.D. in Educational Policy and Administration from the University of Minnesota. His home campus is Johnson.

A coordinator for the Office of Graduate Studies has yet to be named.

#### Dean of Nursing and Health Sciences Sarah Billings-Berg

Sarah Billings-Berg has been employed at Vermont Technical College in the nursing program since 2014. She has served as the Nursing Regional Site Director, Associate Dean of Nursing Education Programs, and as the Health Services Coordinator. Her oversight includes multi-site, statewide nursing programs. She holds a Doctorate of Nursing Practice from Touro University Nevada School of Nursing. Her home campus is Randolph.

### **New Student Experience Updates**

Planning for the Spring and Fall 2024 recruitment cycle is underway. The team is reflecting on the past year to see what worked well and where there are gaps with opportunities to improve going forward. As transformation continues, we are entering a cycle of continuous improvement. A draft of a strategic enrollment and marketing plan is in the final stages of review and we are excited to share it very soon. Special consideration is being made to strategically engage with all the student populations served by Vermont State University across multiple platforms including an enhanced academic program digital marketing campaign. Summer is one of the busiest times of the year in enrollment services and we are excited to launch into the future.

### **Student Success Updates**

All Student Success staff are focused on ramping up for the fall semester and being ready to serve all VTSU students. Many staff are adjusting to different roles, working with new colleagues, and, most impactfully, implementing new processes that are often dependent on new forms, software, reports, or queries. We are navigating a lot that is "new!" I want to commend all team members for their patience, perseverance, and flexibility as we work through a number of glitches, surprises, and challenges. The collaboration and focus on "student first" are admirable as you employ solutions-based approaches and get results. Thank you, Student Success teams!

#### Recent highlights include:

- Over 1,000 new students have completed Vermont State 101, our online orientation program. If you missed it previously, <u>complete Vermont State 101</u> interactively just like a student via this faculty/staff link.
- Over 650 or 63% of eligible students are either fully registered or registered for their major courses. One-on-one meetings to confirm and adjust schedules with Student Success Advisors are occurring daily.
- Over 400 students and guests are registered to attend a Vermont State Summer Days events.
- The Vermont State University Handbook is available on the Vermont State portal.
- New parking permits are available for students, faculty, and staff on the Vermont State portal under Quick Links.
- Many additional student links are 'live' on the Vermont State portal, with more added every week.
- Vermont State's inaugural Dean of Students, Jamia Danzy, began work on July 10 and will be visiting all campuses in the coming weeks to meet with students and staff.

### **Academic Program Updates**

We are pleased to announce that the Graduate Catalog has been completed with new program and policy information (<u>Link – choose Graduate Catalog from the drop down at the top</u>). A big thank you to all of the faculty and staff who brought this project to fruition.

We have faculty and staff working on a number of critical projects this summer. One of those that we are getting ready to kick off shortly is a project we are calling Optimization 2.0. Last December, faculty completed their significant optimization work that culminated in a single program array, which became our first <u>undergraduate and graduate catalogs</u> for VTSU. This was a huge milestone for our new institution. With that work complete, we are now looking forward as part of Optimization 2.0 to making further refinements to our programs to better align them with the university mission, build in further differentiation, and ensure that they can meet sustainability targets. More information on this initiative will be provided next month after it gets kicked off with faculty and staff.

#### **Administrative Operations**

We have some exciting updates from Finance and Operations. The new general ledger account numbers have been launched for Vermont State University and VSCS Shared Services. The new account numbers

reflect the revised structure of the organization and are the culmination of more than eighteen months of work. The initial budget for Vermont State University using these new numbers will be loaded this week. Revisions to the p-card processing system, Works, and WB Mason, to reflect the new general ledger numbers will be finalized within the next two weeks. With the launch of the new account structure, budget reports will now be available using self-service. If you are a budget manager, stay tuned for information regarding training on the new process.

Additionally, the Employee Services and Financial Ops teams are continuing to identify and prioritize the projects that will be part of the next phase of Transformation that is kicking off this summer, and Alumni and Development is beginning intensive work with their vendor Blackbaud to merge alumni databases.

Facilities is continuing to move forward on the Campus Master Planning work, and IT is wrapping up a number of systems projects and getting ready to launch others. Updates from the Master Planning initiative and IT Shared Services are provided later in this newsletter.

### VTSU Facilities Master Planning Update



On June 22nd VTSU kicked off the first of the Campus Master Plan Working Group sessions. This working group will be the primary participants in the development of the master plan along with our partners DumontJanks <a href="http://dumontjanks.com/">http://dumontjanks.com/</a>. The work will consist of helping us acquire, interpret and formulate various data points, gather information, test ideas, evaluate various solutions, provide recommendations, and assist in keeping the working group's members' professional and campus peers

informed about the work of the group. The first meeting went very well, and the participants shared their passionate commitment to finding a sustainable path forward for the challenging work ahead. 
